However, Rogers Bandalero Ranch cannot and will not be held liable for death, injury, or sickness to your horse.

***Inherent Risks and Assumption of Risk:** The undersigned acknowledges there are inherent risks associated with equine activities such as described below, and hereby expressly assumes all risks associated with Pasture Turn Out activity. The inherent risks include, but are not limited to the propensity of equines to behave in ways such as, running, bucking, biting, kicking, shying, stumbling, rearing, falling or stepping on, that may result in an injury, harm or death to persons around them; the unpredictability of equine's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals; certain hazards such as surface and subsurface conditions; collisions with other animals; the limited availability of emergency medical care; and the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within such participant's ability.*

### **Pasture Turn-Out Rules**

Pasture Turnout is based upon availability; the breeding program has precedence when availability is a concern. Twice a year we will close the pasture and prepare the ground for re-seed. This process takes a minimum of 8 weeks to complete and be ready for horses to go back out into the pastures.

Pasture Turnout is \$30 per month and will not be pro-rated. This fee includes turnout 3 days per week for a 30 minute period of time.

#### **RULES:**

- 1) The 30 minute period is NOT to be broken up into several smaller sessions or combined into longer sessions. (i.e. your horse may not be turned out twice for 15 minutes at a time to equal a 30 minute period or for an hour to make up for 2 sessions.)
- 2) Only trainers, trainers' staff or Bandalero staff may turn the horses out into the pastures. Owners may NOT turn their own horses out in the pastures.
- 3) Pasture Turnout is a flat fee and will not be prorated.
- 4) The breeding program has precedence when it comes to pasture availability as this was the original intent for the fields.
- 5) Pasture Turnout is billed at the end of the month for which the horse was turned out.
- 6) This form and the Pasture Turnout Release of Liability form must be completed AND turned into the office PRIOR to the horse being turned out.

Failure to comply with the above rules, can and will result in loss of pasture privileges.
